The DCHC MPO is required by federal regulations to prepare an annual Unified Planning Work Program (UPWP) that details and guides the urban area transportation planning activities. Funding for the UPWP is provided on an annual basis by the Federal Highway Administration (FHWA) and the Federal Transit Administration (FTA). The UPWP must identify MPO planning tasks to be performed with the use of federal transportation funds, including highway and transit programs. Attached is the draft FY 2017 UPWP. The proposed schedule for UPWP development is as follows: draft FY2017 UPWP is reviewed by the MPO Board and released for public comment on January 13, 2016. The MPO Board will hold a public hearing and approve the plan on February 10, 2016.

**Board Workshop -- Goals/Objectives/Performance Measures**[16-110](#)

Immediately following the January 2016 MPO Board meeting, staff will conduct a workshop among Board members to draft the Goals, Objectives and Performance Measures for the 2045 MTP. Key tasks in the schedule that will follow the workshop include:

- Staff will evaluate the feasibility of the Performance Measures proposed in the workshop and prepare a draft Goals, Objectives and Performance Measures document for the February Board meeting.
- The MPO Board will release this document for public comment at their February meeting.
- The MPO Board will hold a public hearing on the draft document at their March 2016 meeting.
- The MPO Board will consider adopting a final Goals, Objectives and Performance Measures document at their April 2016 meeting.

Note that in this schedule there will be many opportunities to review and suggest changes to the draft document after the workshop. Staff wants to use a format that will directly align the Goals, Objectives and Performance Measures and to ultimately adopt a document that is the same for both the DCHC MPO and the CAMPO (Capital Area Metropolitan Planning Organization). Differences between the DCHC MPO and CAMPO versions of this document, however, can be accommodated if needed.

A draft Goals, Objectives and Performance Measures document is attached and will be used as a starting point for the workshop. In addition, the current Goals, Objectives and Targets (from the 2040 MTP) are attached and there are links below to MPOs that have a venerable set of Goals and Objectives.
