The TPO has been advised that the FFY 2025 5307/5340 partial apportionment for the Durham-Chapel Hill-Carrboro Urbanized Area is \$4,448,963.00. In consultation with the City of Durham (GoDurham), Chapel Hill Transit, GoTriangle, and Orange Public Transit, it has been decided to split the allocation between the four fixed route transit operators within the urbanized area. Amendment #7 to the FY2024-33 Transportation Improvement Program (TIP) contains the programming of Federal Transit Agency (FTA) 5310 funds from the Triangle West TPO 2024 Program of Projects, the addition of funding to TA-4726 for replacement buses in Chapel Hill, and the March Item N.

At the February Board meeting, the Triangle West Board authorized staff to bypass required public comment periods to amend the TIP should the executive director determine that an expedited process is needed. This was granted to staff in response to reporting requirements that have been received from FTA. The reporting from FTA are meant to identify all planned Transit Award Management System (TrAMS) applications and amendments for FY25.

**8. Triangle West TPO Draft Regional Safety Action Plan**[25-129](#)**Colleen McGue, TPO Planning Manager**

Over the past nine (9) months, the Triangle West TPO has been in the process of developing a regional safety action plan to improve transit, pedestrian/bicyclist and highway safety throughout the Triangle West planning area. The attached draft plan includes a snapshot of the crash types, severities, and locations and identifies strategies for improving overall safety in the region. This draft plan is the result of the data analysis, community engagement, and stakeholder discussions that have taken place over the course of this planning effort.

Throughout the month of March and early April, Triangle West staff are partnering with member agencies and community-based organizations around the region to host public workshops and pop-up events to share the draft plan with the community. The comments received and discussions at these engagement events will be reviewed incorporated into the draft plan during the public comment period.

The schedule for plan adoption is:

- March 11, 2025: TC recommends Triangle West Board release the draft plan for public comment.
- March 25, 2025: Triangle West Board releases draft plan for public comment.
- April 8, 2025: TC recommends Triangle West Board adopt the Safety Action Plan.
- April 22, 2025: Triangle West Board adopts the Safety Action Plan.

**9. Draft 2026-2035 State Transportation Improvement Plan (STIP) Update** [25-128](#)**Filmon Fishastion, TPO Staff**

The draft 2026-2035 STIP was released on January 29, 2025. This draft includes new projects that were recently awarded funding from the Statewide Strategic Prioritization 7.0 Cycle. Due to limited funding availability, new projects were selected for funding in only four (4) Strategic Transportation Investment (STI) categories: Statewide Mobility, Regions C and D, and Division 6. Triangle West TPO did receive funding for new projects, and TPO staff are working closely with NCDOT to understand schedule changes and that are affecting existing projects in the draft STIP. These are outlined in the attached presentation.

NCDOT has been running a public comment period from January 31, 2025 to April 4, 2025 with drop in sessions between February 17 and March 17, 2025. The final STIP is expected to be adopted in July, 2025.

In the attachments are a presentation outlining the process for the development of the draft STIP and an update on the statewide prioritization process and locally selected projects. Also attached are tables comparing the two categories of projects.
