The City of Durham is seeking a Comprehensive Transportation Plan (CTP) Amendment for an alternative alignment to Massey Chapel Road. A traffic memorandum provided by Kimley-Horn and Associates, Inc. describes the proposed change to the CTP alignment is provided as an attachment for this item. An 45-day public comment period has been completed, a public notice was mailed to 45 property owners within proximity of the existing alignment as required by the City of Durham. #### 9. 2055 MTP - Preferred Scenario

In April 2025, a presentation was given that provided an overview of the MTP alternatives and evaluation. In June 2025, a draft preferred option was developed based on the established goals and objectives, as well as the results of the alternatives analysis. This draft was presented at TC and board meetings and later discussed in meetings with member agencies. Staff received feedback from all these meetings about the further modifications.

The presentation file, which includes the Preferred Option report as an attachment, contains tables and online maps of the project lists in the Preferred Option, along with socio-economic data, TRM model results, measures of effectiveness, and other related items that will be presented at the meeting.

**TC Action**: Recommend that the TWTPO Board authorize staff to release the Preferred Option and results for a 42-day public comment period.

## 10. 2026-2035 TIP Adoption and AQ Conformity

The North Carolina Board of Transportation adopted the FY2026-2035 State Transportation Improvement Program (STIP) at their July meeting. To implement the program, the TPO Board is required to adopt the Triangle West Metropolitan Transportation Improvement Program (MTIP). The STIP and the TIP must match for the first four years of the program.

The TIP went out for public comment from June 23-July 23. The draft TIP is attached for your review.

Included with this item is the Air Quality Conformity Determination Report (AQ CDR) for the Draft TIP/STIP. This report demonstrates that certain pollutant emissions from the future transportation sector will not exceed a specified threshold. It is required to be ran with any adopted MTIP or with any amendment to the MTP. Also included on this item is the schedule for TIP Amendments to the FY2026-2035 STIP.

**TC Action:** Recommend that the TWTPO Board adopt the 2026-2035 TIP and AQ Conformity Document.

## 11. <u>SPOT Process Update</u>

## Filmon Fishastion, Transportation Planner

The Strategic Prioritization of Transportation (SPOT) process is a data-driven approach for ranking projects across North Carolina. Projects are scored based on mode of transportation, degree of impact (statewide, regional, division), and other critical factors. This process takes several years and determines the prioritization of projects in a future funding cycle. This upcoming SPOT cycle is the 8th iteration of the scoring process and projects will be funded for the FY2028-2037 STIP.

Earlier this year, members were asked to submit requests for projects that have not already competed in a SPOT cycle in the past. This list of new submissions have been added to the list of Holding Tank projects (submissions from P7.0 that were not selected for funding) and the list of projects that were considered for submission in P7.0 that ultimately did not make the list of submissions. This combined list of all projects being considered for P8.0 went out for public comment from June 23-July 23. A subcommittee of the TC met earlier in August to narrow the list of projects. The final recommended list to be adopted in September will take into consideration the comments received, the project scores from P7.0, and local priorities.
